II. President's Report

III. Treasurer's Report

We are behind our goal for Family Giving by \$30,000. Our goal is \$120,000 and we are currently at \$90,688. We are still encouraging people to donate and leverage company matching. Auction brought in \$96,050. Overall goal for revenue is \$233,000 versus actual of \$191,000. Some of the gap has been reduced with savings on expenses. Senior dues are still coming in. Overall we are under by \$18,000 versus projected \$25,000.

Suggestion was made to send Family Giving totals by family on an ongoing basis, to encourage additional giving. Principal Jenkins stated that in-person meetings will also help with increasing Family Giving.

Budget for 2023-2024 was reviewed. The Outward Bound Program will receive limited funding from DOE so PA is supplementing. This budget will be voted on by the PA general membership on June 13.

IV. Principal's Report

Principal Jenkins discussed the importance of PA funding for professional development. Teachers are strongly encouraged to take professional development during the summer.
